Supplemental Provision – California

Last Updated and Effective Date: February 22, 2024

This California Supplemental Provision (the "**Supplement**") supplements the information contained in the <u>Global Privacy Notice</u> for <u>Institutional Clients</u> (the "**Privacy Notice**") and applies solely to individuals who have rights under the California Privacy Rights Act ("**CPRA**") ("**consumers**" or "**you**"). Unless otherwise defined in the Privacy Notice, any terms defined in this Supplement have the meaning used in the CPRA.

Retention of Personal Information

We store personal information for as long as necessary to carry out the purposes for which we originally collected it and for other legitimate business purposes, including to meet our legal, regulatory, or other compliance obligations.

Do Not Track

Some browsers have a do not track feature that lets you tell websites that you do not want to have your online activities tracked. At this time, we do not respond to browser do not track signals.

Selling or Sharing of Personal Information

We do not sell your Personal Information or share your Personal Information for cross-context behavioral advertising, and have not done so in the prior 12 months. We also do not knowingly sell or share the Personal Information of children under the age of 16, and have not done so in the prior 12 months.

Your Rights and Choices

Applicable privacy-related Laws may afford consumers residing in the California certain rights with respect to their Personal Information, subject to certain exceptions. Subject to certain limitations, you have the following rights in California:

- (1) <u>Right to Delete</u>. You have the right to request us to delete the Personal Information we have collected about you.
- (2) <u>Right to Correct</u>. You have the right to request us to correct inaccurate Personal Information we maintain about you.
- (3) <u>Confirm Processing</u>. You have the right to confirm whether we are processing your Personal Information.
- (4) Right to Know and Access. You have the right to know and access the Personal Information we have collected about you, including the categories of Personal Information, the categories of sources from which the Personal Information is collected, the business or commercial purpose for collecting, selling, or sharing Personal Information, the categories of third parties to whom we disclose Personal Information, and the specific pieces of Personal Information we have collected about you.
- (5) <u>Data Portability</u>. You have the right to receive the information under right (4) in a format, to the extent technically feasible, that is portable, usable, and allows you to transmit the Personal Information to a person without impediment, where the processing is carried out by automated means.
- (6) Rights Related to Sharing for Cross-Context Behavioral Advertising or Sale. We do not share your Personal Information for cross-context behavioral advertising or sell your Personal Information. Please contact us by using the information in Contact Us below if you have any questions.
- (7) <u>Right to No Discrimination</u>. You have the right not to be discriminated against for exercising any of your privacy rights. This includes us not: (a) denying you goods or services; (b) charging you different prices or rates for goods or services, including through the use of discounts or other benefits or imposing penalties; (c) providing you a different level or quality of goods or services;

and (d) suggesting to you that you will receive a different price or rate for goods or services or a different level or quality of goods or services.

Exercising Your Rights

To exercise your rights described above, please submit a verifiable consumer request to us by either:

We will need to verify your identity before honoring your privacy rights request. We will verify your identity by asking you to provide Personal Information we may have previously collected about you. Subject to certain limitations, we will honor your privacy rights request within 45 calendar days of receipt of your request, unless we request an extension as permitted by applicable Laws.

Authorized Agents

You may exercise your privacy rights through an authorized agent. If we receive your request from an authorized agent, we may ask for evidence that you have provided such agent with a power of attorney or that the agent otherwise has valid written authority to submit requests to exercise rights on your behalf.
